### CHANGE TO PRICE OF DIGITAL TATTOOS IN 2026

The Thoroughbred Racing Protective Bureau (TRPB) is advising horsemen that effective January 1, 2026, the **cost of TRPB Digital Tattoo® Certification** will be set to US \$115 / CA \$160, plus any sales tax if applicable.

The TRPB's core objective of the horse identification program is to provide a safe and secure means of equine identification at the racetrack on a timely and professional basis. The Digital Tattoo® program launched in 2020 and has proven to be a major success.
